1. The Chairman, Department Procurement Committee on behalf of the Vice Chancellor, University of Vavuniya invites sealed bids from eligible and qualified bidders for the Design, Construction and Commissioning of Four Storied Hostel Building for 200 Students at University of Vavuniya, Pampaimadu, Vavuniya . **Total Construction Cost is LKR 283.0million** (excluding VAT) and the **contract period is 09 calendar months**.

2. Procurement method is National Competitive Bidding Procedure and the Contract type is **Design & Build**.

**“Bidders shall also register themselves with the Registrar of Public Contracts, Sri Lanka, in terms of the Public Contracts Act No 03 of 1987 for the works estimated above Rs. 5.0 million.”**

3. The eligible bidders shall comply with Grade C4 or above in CIDA registration in Building construction.

6. Bid shall be valid up to **11.09.2026** (minimum 147 days from Date of Submission)

All bids must be accompanied by a **Bid Security of LKR 2,500,000.00** which should be in favor of Vice Chancellor, University of Vavuniya, obtained from a Commercial Bank approved by the Central Bank of Sri Lanka valid up to **09.10.2026** (added minimum 28 days beyond bid validity). The bid security should be “on demand” and “unconditional” and on the format given in the bidding document.
8. **Pre-Bid meeting** will be held on **13.03.2026** at the Board Room, Administration Block (IT Centre), University of Vavuniya, Pampaimadu, Vavuniya at **10:00 am**.
9. Sealed bids shall be deposited in the Tender Box at the Office of the Deputy Registrar (Capital Works & Planning Division), University of Vavuniya, Pampaimadu, Vavuniya.

The **deadline for submission of bids** will be **11:00 am on 17.04.2026** and will be opened soon after the closing at the Board Room, Administration Block (IT Centre), University of Vavuniya , Pampaimadu, Vavuniya. Bidders or their authorized representatives are requested to be present at the opening of bids.
